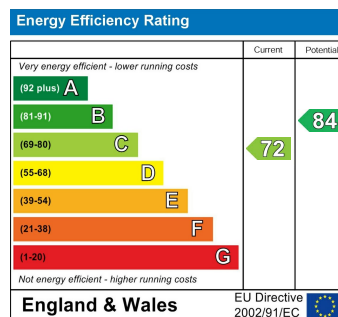
GROUND FLOOR
