Summary of Accommodation

ACCOMMODATION

Entered via a solid wooden door with double glazed side panels into a welcoming hallway benefiting from solid wood flooring, recessed ceiling spotlights and a recessed storage cupboard housing the 'Heatrae' hot water cylinder.

The open plan kitchen/dining/living room benefits from continuation of solid wood flooring, recessed ceiling spotlights and two double glazed windows. The kitchen has been fitted with a range of wall and base units with granite work surfaces. Integral 'Smeg' appliances to remain include; a fridge/freezer, a microwave, an electric oven, a 4-ring electric hob with an extractor fan over, a dishwasher and a 'Baumatic' washing machine. The kitchen further benefits from matching granite upstands, an extractor fan, recessed ceiling spotlights and a bowl and a half stainless steel sink with a mixer tap over.

The bedroom is a double bedroom benefiting from carpeted flooring, recessed ceiling spotlights, a large recessed walk-in wardrobe and a double glazed window.

The bathroom has been fitted with a 3-piece white suite comprising; a mirror panelled bath with a thermostatic shower over, a floating wash-hand basin and a WC. The bathroom further benefits from tiled flooring, tiled walls, a range of wall mounted mirrored storage cabinets, recessed ceiling spotlights, an extractor fan and a wall mounted chrome towel radiator.

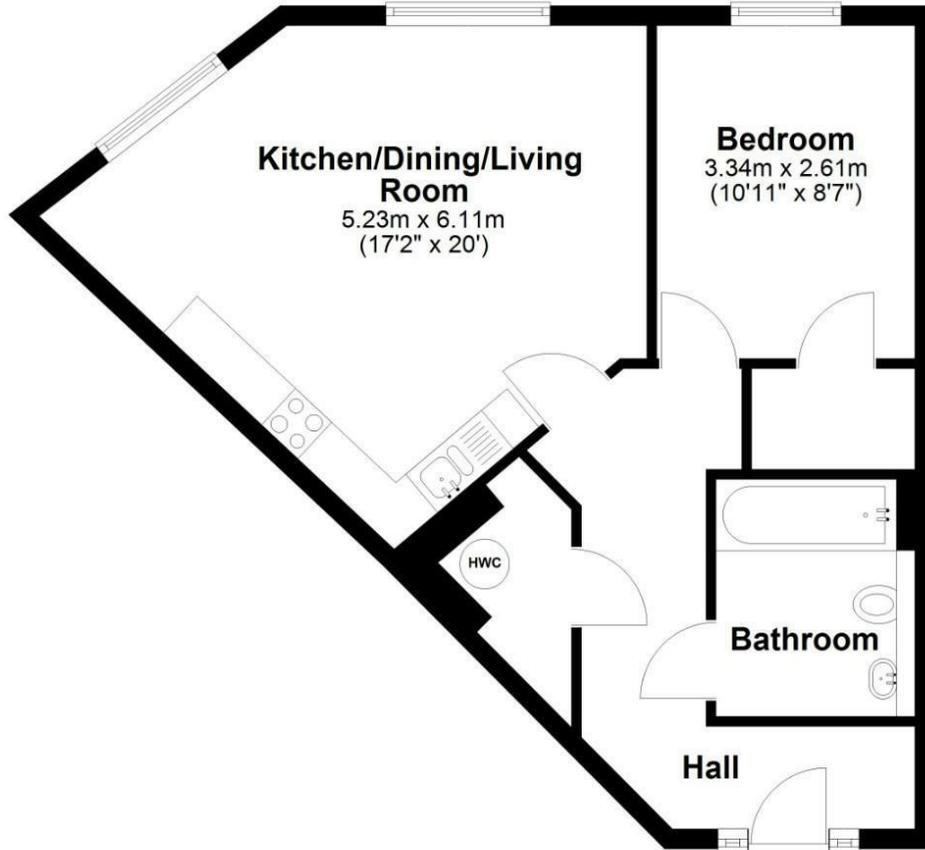
