Location

The property is situated in a convenient location just off Waterton Lane and fronting the A473 dual carriageway opposite the Bridgend Industrial Estate. The property is conveniently located lying just 2 miles or so east of Bridgend Town Centre and 2 miles or so west of Junction 35 (Pencoed Interchange) of the M4 Motorway.

Cardiff lies approximately 20 miles to the east and Swansea 20 miles to the west.

Description

The property is located on a privately owned Trade Park anchored by Wick Van Hire and Sales a long established motor vehicle business.

The property briefly comprises a semi-detached industrial/workshop unit constructed around a steel portal frame with single sheet cladding to roof and elevations. The property features a roller shutter door to the front elevation opening out onto a tarmac surfaced forecourt and car parking area.

The semi-detached unit provides approximately 155 sq.m (1668 sq.ft) Gross Internal Area of Accommodation.
