The property is accessed via its own entrance with stairs leading to the First Floor.

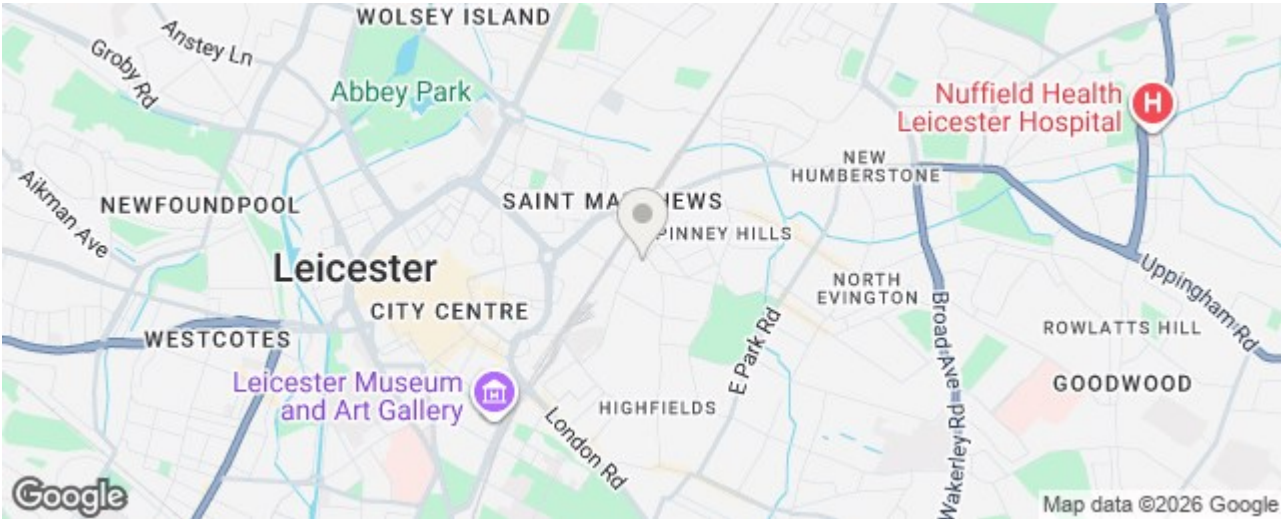
Up a flight of stairs, is a Hallway, which provides access to a bright and spacious Lounge, Bedrooms and the Bathroom.
