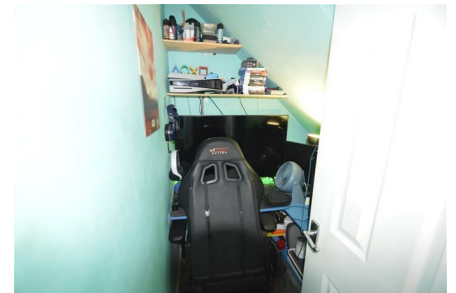

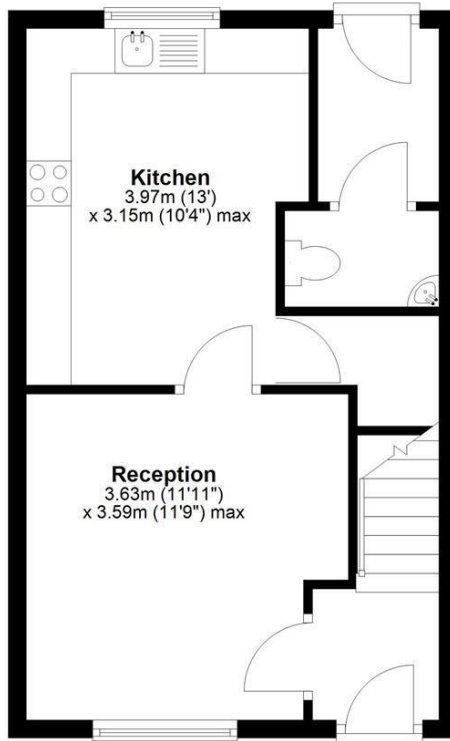

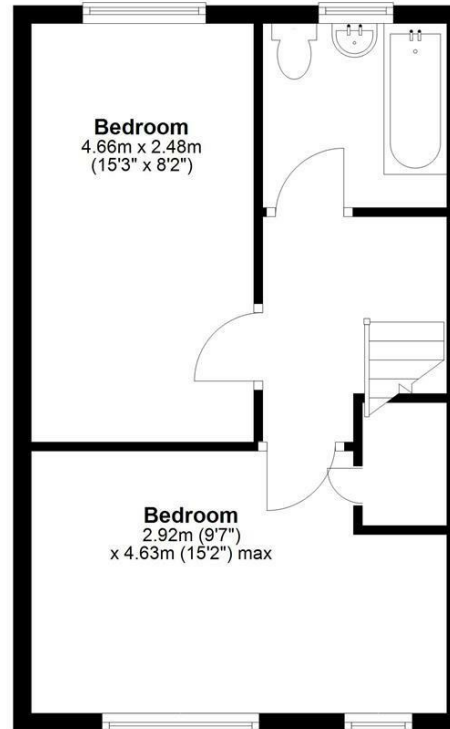
Ground Floor
