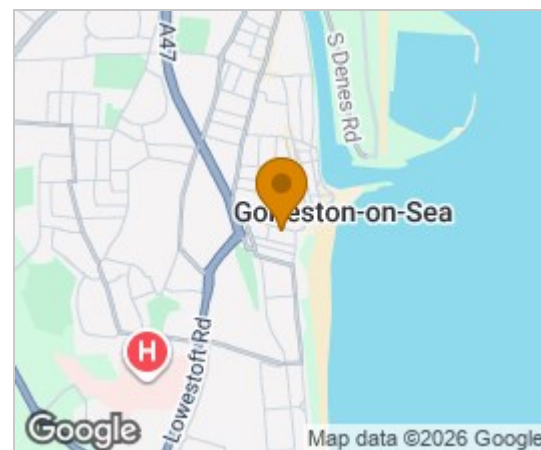

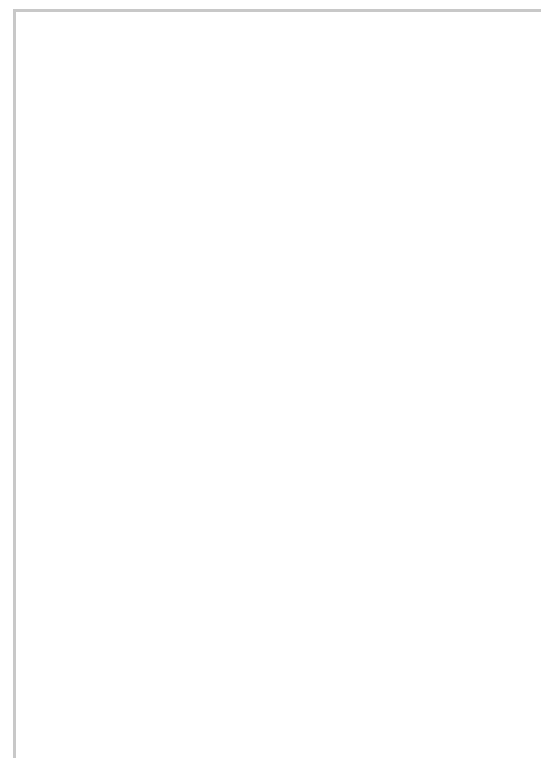
Council Tax Band

Council Tax Band- A

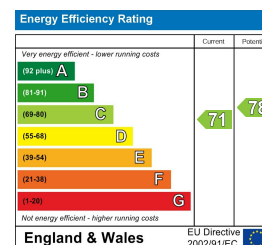
Area Map
