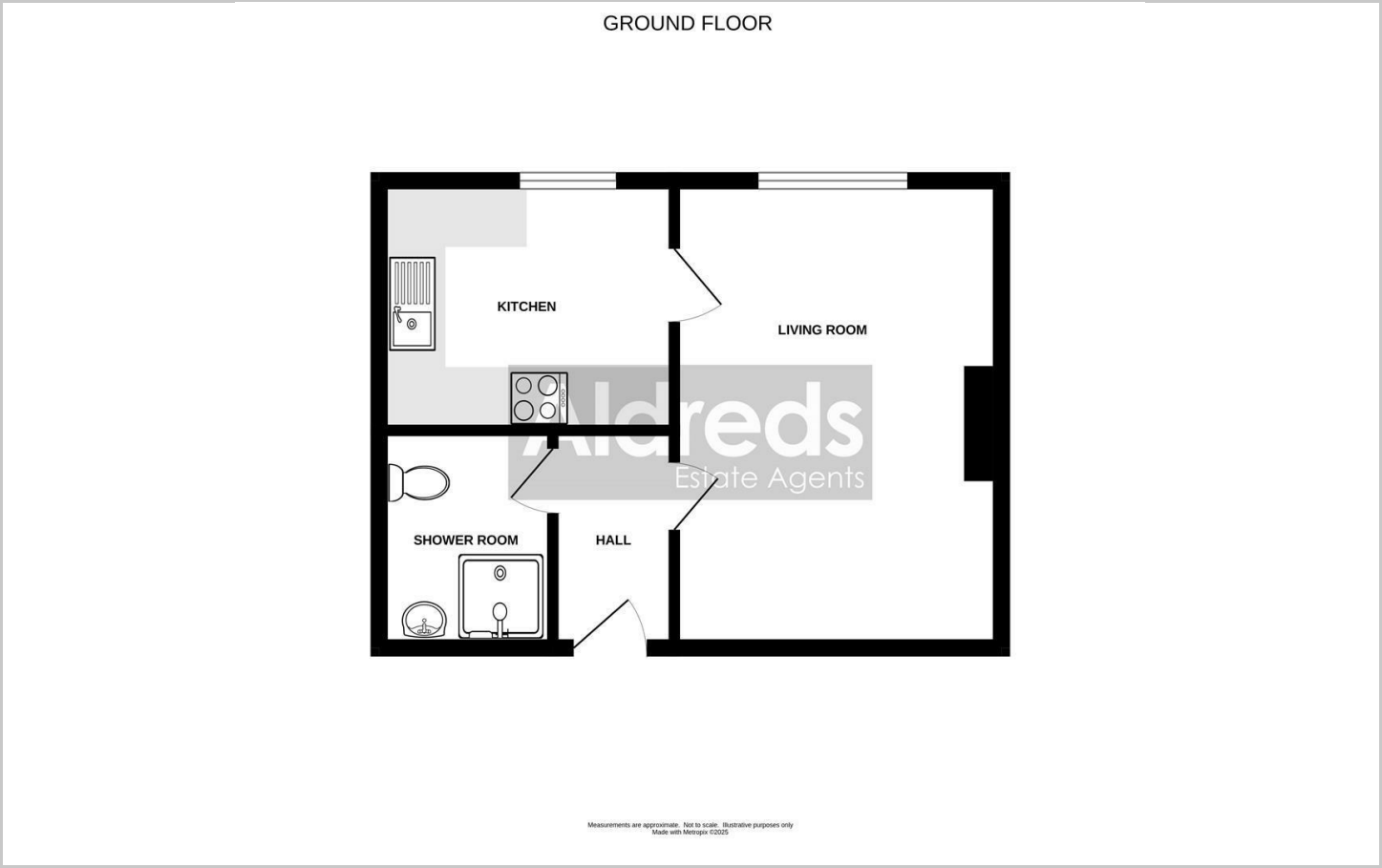

Floor Plans

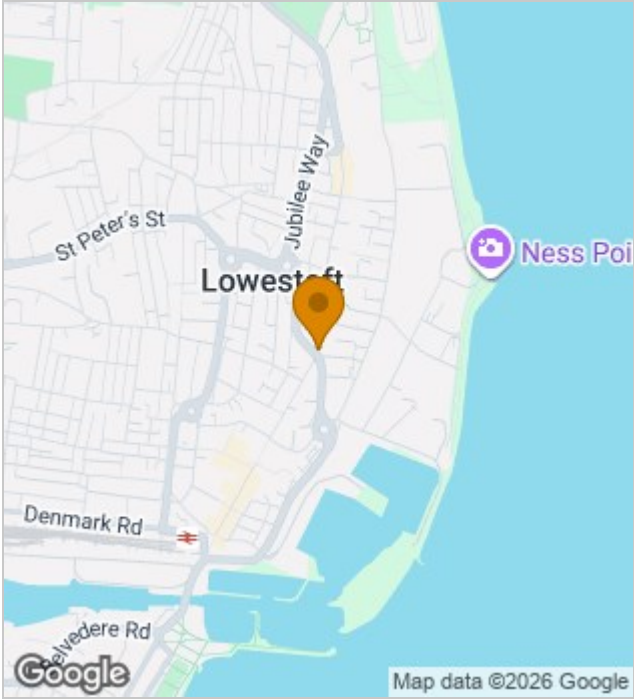
