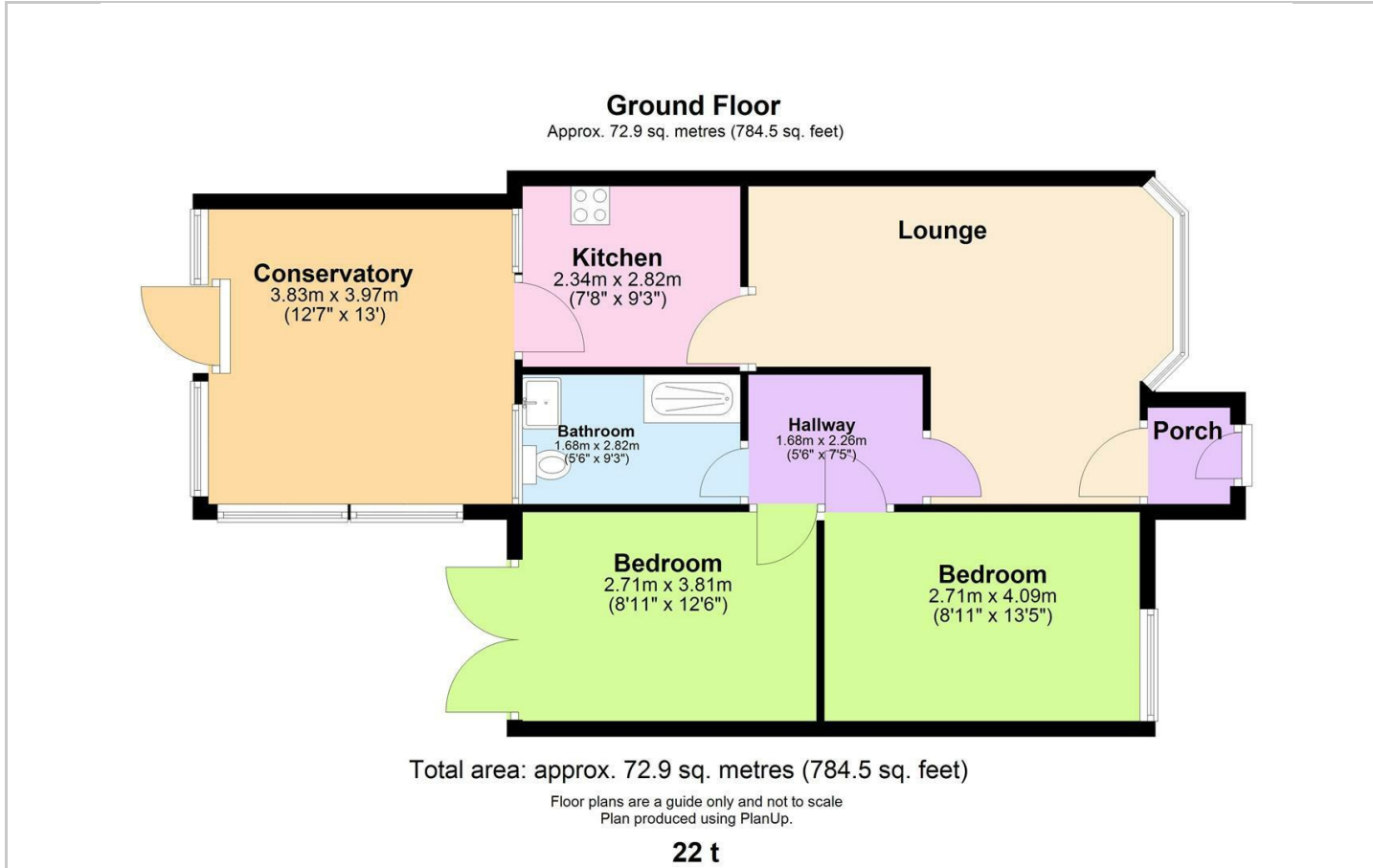

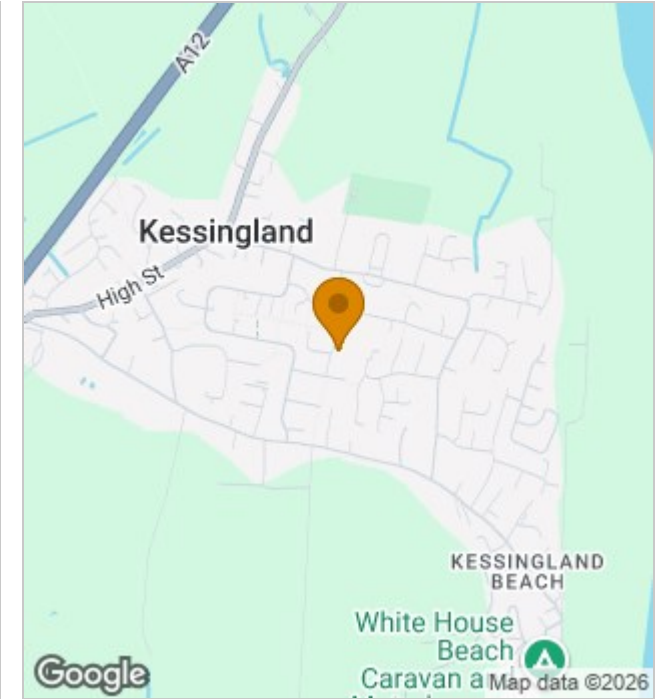

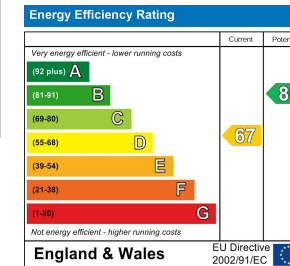
## Floor Plans
