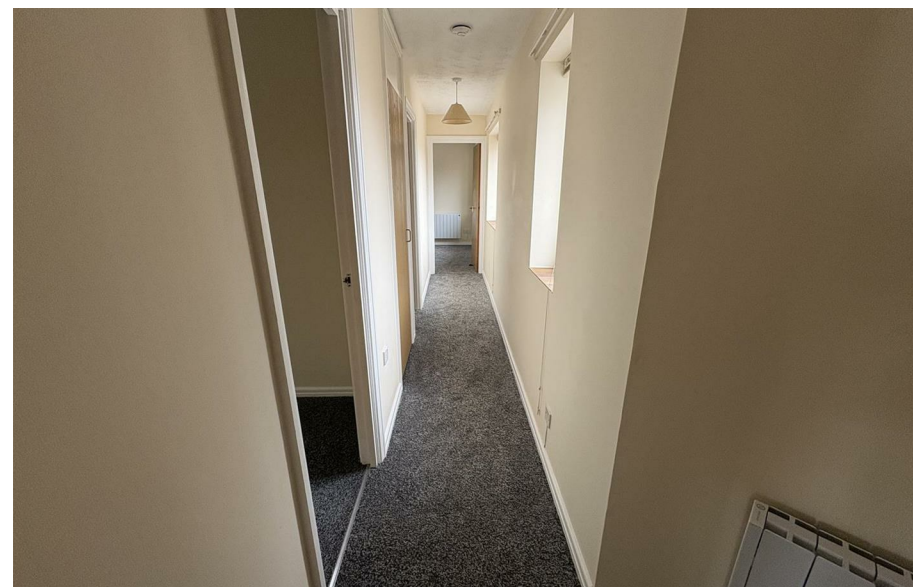

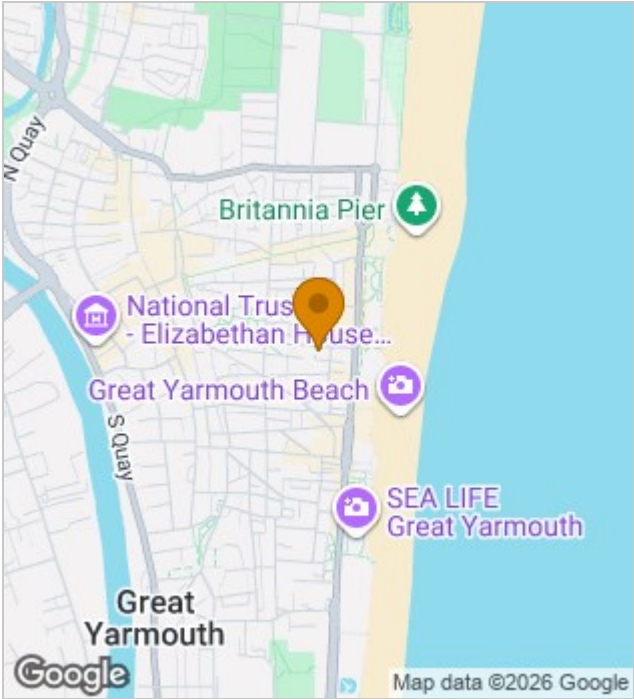
## Council Tax Band

Council Tax Band- B

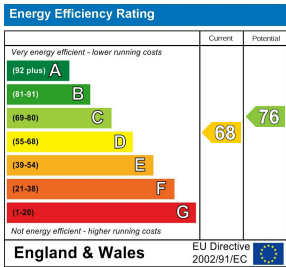
Floor Plans
