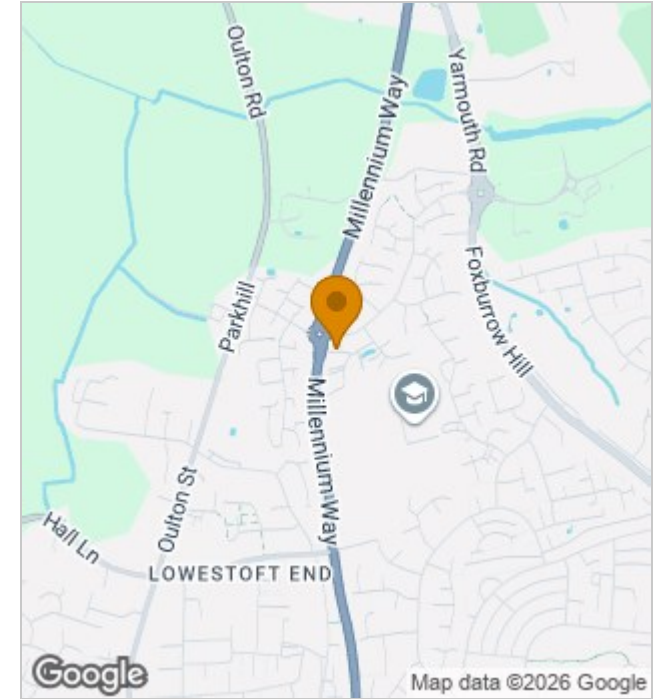

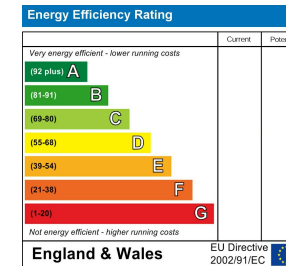
Floor Plans
