Spanning the full width of the property, the stylish open-plan kitchen, dining, and family room forms the heart of the home. The kitchen offers integrated appliances, ample storage, and generous worktop space, while French doors open onto the rear garden, creating an excellent space for both entertaining and everyday family life. A separate utility room provides additional storage and appliance space.

Upstairs are four well-proportioned double bedrooms. The principal bedroom benefits from fitted wardrobes and an en-suite shower room, while the second bedroom also enjoys fitted storage and its own en-suite. A modern family bathroom with both a bath and separate shower serves the remaining bedrooms.

The enclosed rear garden has been thoughtfully landscaped and features a generous patio, lawn, and established planting, providing an ideal setting for outdoor dining, entertaining, or relaxing. 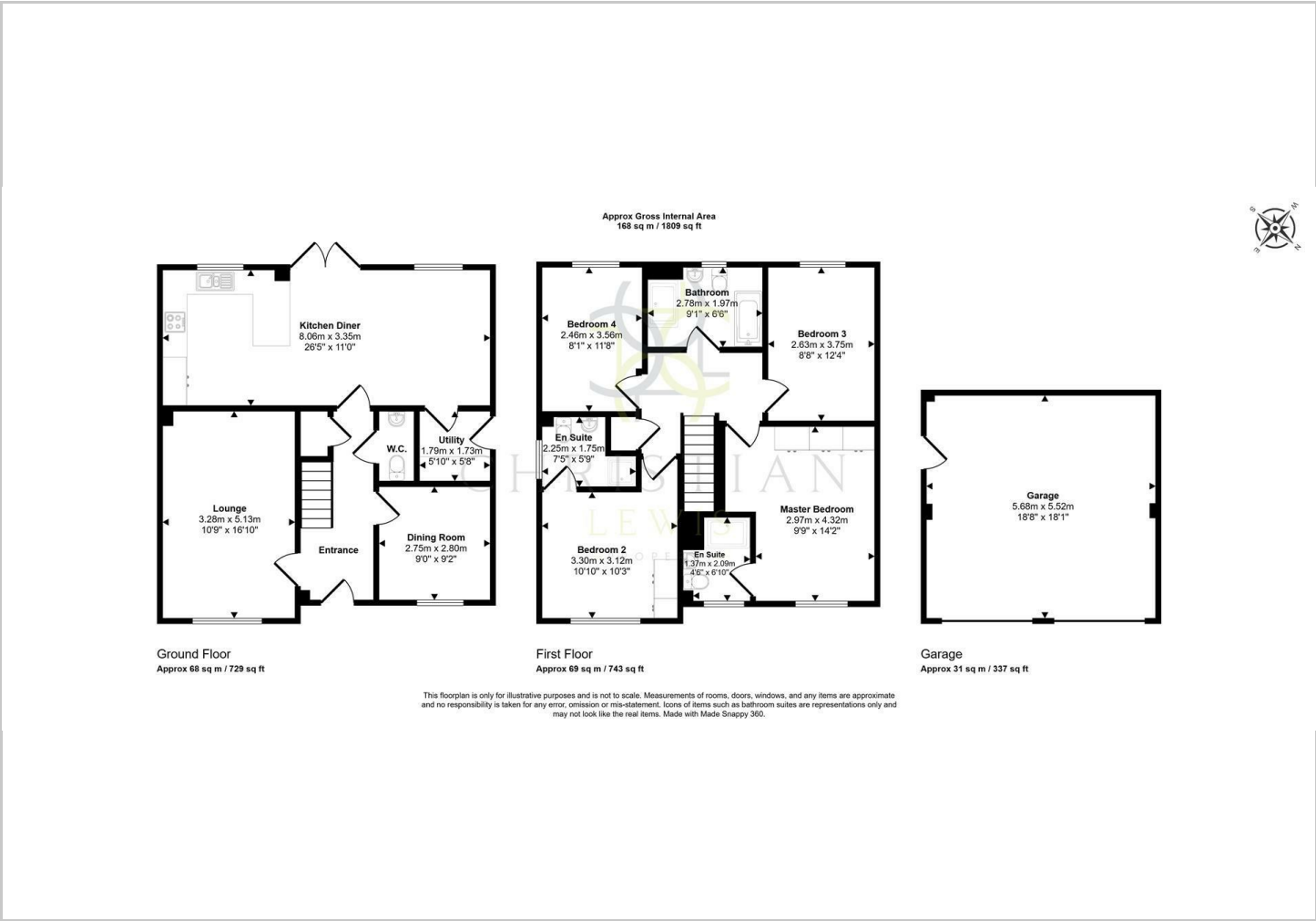

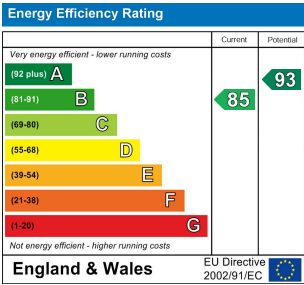
Floor Plans
