Windlass Court sits in the village of Grove, just north of Wantage in Oxfordshire, on the line of the former Wiltshire and Berkshire Canal. The village grew around this historic route, and traces of the canal still run through the parish alongside Letcombe Brook, one of Oxfordshire's rare chalk streams. Grove offers local shops, two primary schools, cafés and green spaces, while Wantage provides wider amenities only 1.5 miles away.

PLOT 1

Occupying a prominent corner position close to the entrance, Plot 1 benefits from a south-east facing frontage that welcomes morning light. This 134m² home provides up to four bedrooms arranged across three levels and benefits from excellent privacy with mature boundaries, creating a secluded garden environment with convenient access to the development entrance.

PLOT 2 & 3

Positioned centrally within the development, Plots 2 and 3 enjoy a south-west facing frontage and benefit from established mature boundaries to the north. These 134m² homes provide up to four bedrooms arranged across three levels and offer excellent natural light during afternoon hours, with the mature northern boundary creating a private and sheltered garden setting.

PLOT 4

The signature plot at Windlass Court, Plot 4 commands the most enviable position within the development. This substantial corner location offers up to 226m² of living space, providing up to five bedrooms arranged across three levels, with a rear garden featuring a south-east facing aspect overlooking the historic Wilts & Berks Canal, creating a unique setting with far-reaching rural views.

PLOT 5

A desirable corner plot close to the entrance, Plot 5 offers a north-east facing frontage with a south-west facing rear garden positioned to capture afternoon and evening sun. This 134m² corner home provides up to four bedrooms arranged across three levels and combines convenient accessibility with enhanced privacy, creating an ideal outdoor entertaining space.

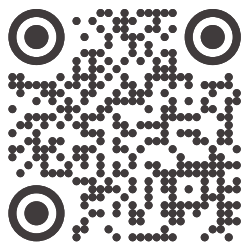
