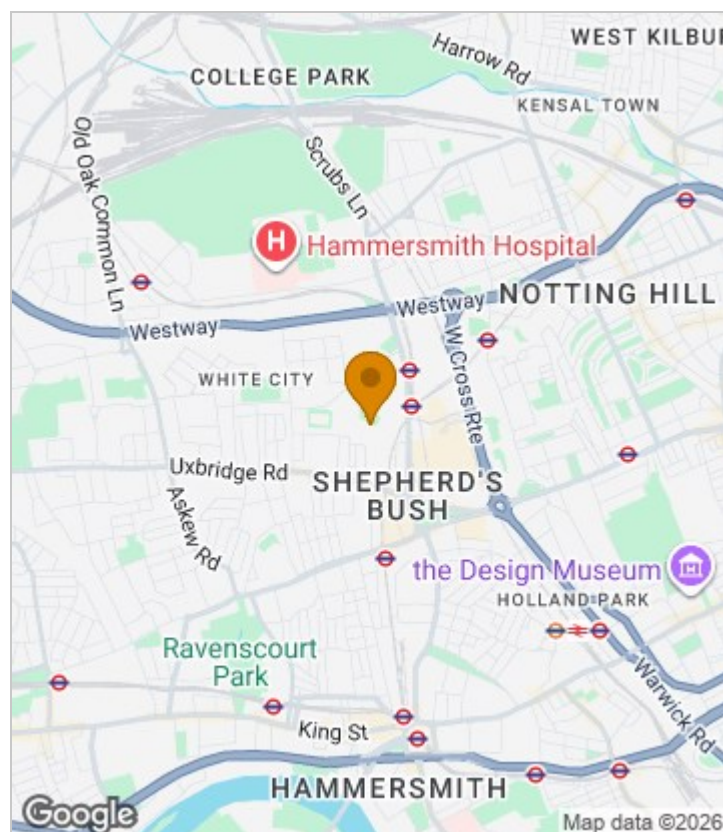

Second Floor

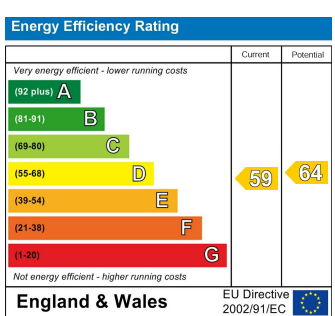
